

## It's Time To Schedule Your Free Tax Through NCEC

Last year, we saved community members \$331,452 in filing fees based on an average cost of \$324.\*

We are excited to be able to offer this free service to members of our community through grants we have received. This free service is available to anyone. You do not have to be a member of Natco Credit Union.

This will be our sixth year to provide this service. The number of community members we assist continues to grow. Our first year, we helped 45 people. In 2017, we assisted 389 people by completing and submitting their taxes for free. In 2018, we prepared and submitted 593 tax returns. In 2019, we prepared and submitted 756 returns and in 2020, we prepared and submitted 1,023 returns despite the challenges of social distancing and our offices being closed to in-person visits.

We have already begun scheduling appointments for FREE basic tax preparation for this tax season through Natco Community Empowerment Center. The money saved in preparation fees goes back into our local community when families are able to spend the money they saved on other things they want and need.

Below is a checklist of items to gather prior to your tax appointment.

- Social Security cards for you, your spouse and dependents**
- Birth dates for you, your spouse and dependents on the tax return**
- Wage and earning statements (Form W-2, W-2G, 1099-R, 1099-Misc) from all employers or payers**
- Social Security benefit statement (SSA-1099)**
- Unemployment benefit statement (1099-G)**
- Interest and dividend statements from banks (Forms 1099)**
- A copy of last year's federal and state returns, if available**
- Bank account routing and account numbers for direct deposit**
- Total paid for daycare expenses and the daycare provider's tax number, such as their Social Security number or business Employer Identification Number**
- Form 1095-A, Health Insurance Marketplace Statement** If you are married and filing a separate tax return you will need your spouse's name, Social Security number, and date of birth
- If you are married and filing a joint tax return, both you and your spouse must be present to sign the required forms**

Tell your family, friends, and coworkers about this FREE service available to anyone in the local community.


## FREEDOM FAST Loans Provide the Assistance Members Need
